Annex ZB (informative)

A-deviations

A-deviation: National deviation due to regulations, the alteration of which is for the time being outside the competence of the CEN/CENELEC member.

This European Standard falls under Directive 73/23/EEC.

NOTE (from CEN/CENELEC IR Part 2, 3.1.9): Where standards fall under EC Directives, it is the view of the Commission of the European Communities (OJ No C 59; 1982-03-09) that the effect of the decision of the Court of Justice in case 815/79 Cremonini/Vrankovich (European Court Reports 1980, p. 3 583) is that compliance with A-deviations is no longer mandatory and that the free movement of products complying with such a standard should not be restricted except under the safeguard procedure provided for in the relevant Directive.

A-deviations in an EFTA-country are **valid instead** of the relevant provisions of the European Standard in that country until they have been removed.

Add:

22.5.18 and

22.10.1 **Denmark** (Heavy Current Regulation, Section 6, subclause 805.56) **France** (Regulation relating to security in public establishments, Art. EL 10 Clause 1).

In premises open to the public, electrical installations shall have only permanent

fittings. Consequently, the external plug and socket connections not having a provision against accidental disconnection are formally forbidden.

22.1 Scope

Replace the second paragraph by the following new text:

This section does not cover the effects of non-emergency voltage reductions on luminaires incorporating high pressure discharge lamps.

Page 13

22.5 Marking

Replace the existing introductory paragraph by the following new text:

The provisions of section 3 of IEC 60598-1 shall apply together with the requirements of 22.5.1 to 22.5.19 below.

Page 15

Subclause 22.5.18

Replace the existing text of subclause 22.5.18 by the following new text:

The mounting instructions for luminaires intended for external plug and socket connections, without provisions to prevent accidental disconnection, shall be provided with the warning: "This luminaire is intended only for mounting in locations where the plug and socket are protected from unauthorised disconnection".

Add the following new subclause:

22.5.19 Compliance with the requirements of 22.5.1 to 22.5.18 is checked by inspection.

Page 23

22.10 External and internal wiring

Replace the existing text of subclause 22.10.1 with the following new text:

22.10.1 Electrical connections to the mains, between separate parts of the luminaire (e.g. remote control gear box) and between luminaire components shall be protected against the risk of accidental disconnection. Electrical connections shall be permanent or have a provision to prevent accidental disconnection. Internal plug and socket connections not having a provision against accidental disconnection are accepted if direct access to them is prevented (e.g. protected by a cover that cannot be removed by a single action with one hand). External plug and socket connections not having a provision against accidental disconnection are accepted if the luminaire is provided with a warning as required by subclause 22.5.18.

NOTE In France and Denmark a permanent connection is required by the safety lighting regulation.

Compliance is checked by inspection.
